Not eligible for voting privileges or to serve as officers of the association.

INDIVIDUAL TRADE Qualifications: An individual person who is an independent sales representative not actively engaged in the practice of funeral directing or embalming, but is doing business that is directly connected to the profession of funeral directing and embalming including, but not limited to, supplies, insurance and financial companies, cemeteries, and third party pre-need sellers. Not eligible for voting privileges or to serve as officers of the association.
